# **December Bee Culture Photo Contest Rules**

#### To enter:

To enter, submit your original photo via upload at <a href="www.facebook.com/beeculture">www.facebook.com/beeculture</a> and agree to the Photo Contest Consent/Release Form. A maximum of 5 photos will be allowed per contestant. Save all original files used in your entry in the event that you are selected as a winner. NO PURCHASE NECESSARY.

Entries must be received by 11:59 p.m. CDT, December 31, 2016. Late entries will not be accepted.

### **Eligibility:**

Must be 13 years or older to enter. Open to everyone within the U.S. and Canada.

Employees of Bee Culture and their immediate families (spouse/domestic partner and any children living with the employee) are not eligible to participate.

Entries will not be judged unless the entrant's name, address, city, state, email, phone number, name of everyone in the photo and photo description are included with each entry. You must have permission for that photo to be published, and by submitting it to us, you acknowledge that fact. You are welcome to submit more than one entry for consideration up to 5 photos per individual contestant, but each online entry must be submitted separately.

Photographs may be processed commercially but must have been taken by the entrant.

## Timing:

Contest opens December 5, 2016

Deadline for submissions: 11:59 p.m. CDT, December 31, 2016.

Winner will be notified by January 6, 2016.

#### Theme:

The contest theme is Merry Christmas honey bees/decorative hives. Entries will be judged on their ability to meet the judging criteria below.

#### Selection:

All entries will be judged by a committee of judges for adherence to the judging criteria below. Decisions of the judges are final.

## **Judging Criterion:**

The winner must show at least one of the following basic rules of photography (30%):

- Rule of Thirds
- Repetition
- Emotion
- Depth of Field
- Selective Focus
- Vantage Point/Point of View
- Angle
- Contrast
- Filled Frame
- Framing

- Leading Lines
- A single person photo that showcases reflection
- A couple photo that showcases relationship
- A small or large group that showcases interaction

Quality (40%) Creativity/Originality (30%)

#### The Prize:

### **Photo Requirements**

All submitted photos must meet the following size requirements:

- File size: Up to 50 MB
- File Format: JPEG, PNG or GIF.
- 300 dpi, roughly square
- CCD: 5 megapixel minimum
